

Waiver and General Release of Claims and Covenants Not to Sue

I, the undersigned, fully understand, appreciate and agree that I have voluntarily requested to participate in an event at MAPFRE Stadium in Columbus, Ohio (the "Event"), which will involve my attendance and the attendance of one dog that I own and of which I have custody, at MAPFRE Stadium in Columbus, Ohio. I understand that by participating in the Event, my actions may result in anticipated and/or unanticipated injuries and damage to myself and others including without limitation my dog; as well as the dogs of others. I hereby represent that the dog of which I have custody during the Event is in good health. I hereby represent and warrant that my dog's vaccinations are all current. I understand that my dog must remain leashed at all times during the Event, and that I must clean up and properly dispose of any waste produced by my dog. I agree to abide by any decision of any Columbus Crew SC (the "Club") official concerning my ability, or the ability of my dog, to participate in the Event safely, and I further agree that Club officials may authorize necessary treatment for me and/or my dog. I assume any and all the risks associated with my participation and the participation and actions of my dog in this Event including, but not limited to, risk of or associated with injury and property damage including injury to other dogs and humans, illness, falls, contact with spectators at the Event, injuries or damages sustained by and through other participants' dogs, the effects of the weather including extreme temperatures and humidity, the condition of the premises and MAPFRE Stadium, including all sidewalks and parking lots, and it is understood and agreed that all such risks are understood and appreciated by me. I agree to abide by all the rules and instructions given in connection with this Event, including without limitation the rules of the Event posted by the Club. I assume the risk for injuries and damages sustained by me or my dog as a result of the manner and method by which the Event is administered. I, the undersigned, have read this waiver and I am competent and of legal age to sign the waiver with full understanding of the above information. In consideration for allowing me to participate in this Event with my dog, I hereby for myself, my heirs, executors, and administrators or anyone acting on my behalf, waive, release, and covenant not to sue and full indemnify and hold harmless and discharge Team Columbus Soccer, L.L.C., a Delaware limited liability company; Crew Soccer Stadium Limited Liability Company, a Delaware limited liability company and Major League Soccer, LLC and each of their respective parents, affiliates, predecessors and successors, owners, agents, partners, Board of Commissioners, officials, employees and representatives, any sponsor of the Event, suppliers, agents, and independent contractors or other personnel in any way assisting or connected with this Event from any and all claims, demands, or causes of action of any kind arising out of my participation and the participation and actions of my dog in this Event, regardless of who causes the injury or damage sustained and regardless of whether based on fault or negligence. I understand that my dog will not be allowed admittance unless and until I agree to assume full responsibility for the actions of my dog. I hereby grant Team Columbus Soccer, L.L.C., a Delaware limited liability company; Crew Soccer Stadium Limited Liability Company, a Delaware limited liability company and Major League Soccer, LLC the perpetual right to use for publicity or promotional purposes, my name or pictures of me and my dog in any media without any liability or obligation to me.

THE UNDERSIGNED HAS READ, UNDERSTANDS AND VOLUNTARILY SIGNS THIS AGREEMENT, and further agrees that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.
